Recognition of Prior Learning (RPL) & Recognition of Current Competence (RCC)

Do you have prior qualifications and/or experience gained through years of work in skilled and challenging jobs? Gaining recognition of these skills is sometimes not easy and can hold you back in progressing your career to the next step. If this is your situation, you can unlock your full potential by having your skills recognised by ACFB!

All applications for RPL/RCC are considered by ACFB's Program Manager. Please note, ALL applications for RPL/RCC MUST be accompanied by the requested performance evidence outlined within this document and will be submitted during Stage 2 of this process.

How does the RPL process work?

There are two (2) stages to the RPL/RCC process:

Stage 1

- Identify the units that you believe you have the required knowledge and skills, AND where you can provide the performance evidence required
- Pay particular attention to the example evidence you will need to submit if you
 were to apply for RPL/RCC for the unit. You will need to submit evidence to meet
 all the Performance Evidence listed for each unit
- Check the boxes on the left-hand side for each unit where you would like to move forward with the RPL/RCC process
- Email this completed form to rpl@acfb.edu.au
- Make payment of the non-refundable RPL/RCC processing fee of \$100 (please note, this fee will be deducted from your course fee after enrolment)
- ACFB will then send you an RPL/RCC document for each unit checked below

Stage 2

- Fill in the unit RPL/RCC documents sent to you, answering all short answer questions in detail related to your knowledge of the unit
- Submit each RPL/RCC unit document, along with all evidence requested to rpl@acfb.edu.au. Hard copy documents will not be accepted.
- Where RPL/RCC is requested for multiple units, place all evidence for a unit within
 a folder using the unit code as the title, then zip the folder and attach to the email
- ACFB will review your submitted documents and may request further evidence if required (this may also include practical demonstrations and oral questioning)
- You will then receive an RPL/RCC Summary outlining the units where you have successfully gained RPL/RCC and the amended course price (if applicable). Please note this amended price will include a fee per unit for the RPL/RCC process.
- An RPL/RCC application may take between 10-21 business days to process from when we receive your completed unit forms and supporting evidence.

Unit Description:	This unit of competency describes the skills and knowledge required to obtain and interpret information about client health status and to check a client's physical health. It requires a detailed knowledge of anatomy and physiology. This unit applies to individuals working directly with clients and who assist in the provision of health care services.	
Required Evidence:	 The applicant must provide evidence of the following to gain RPL/RCC for this unit: May have completed a similar unit within a health course however there must be evidence of assessing clients (minimum 3) health status based on observations, physical assessments and interpretation of client tests or Have worked within the health industry with clients where health information is analysed and services are planned for clients presenting with a variety of specific conditions The applicant must have industry experience within a health service where direct client contact is involved, this may be within a student clinic during learning Example of other Evidence Relevant certified transcript & certificate with a similar unit of competency, including the unit outline/summary that demonstrates the same performance outcomes, or Evidence of working within the health industry where you have completed the above tasks through letters from employers outlining job role and duties Where work within the industry is primarily used as evidence, submission of client documents (at least 3 different people presenting with different conditions) with client identifiers blanked out, demonstrating the ability to work with clients with a variety of presenting conditions

Unit Description:	This unit describes the performance outcomes, skills and knowledge required to gather client information, make a client assessment and determine massage treatment options. This unit applies to massage therapists providing therapeutic and relaxation massage treatments. It does not include remedial massage assessment techniques.	
Required Evidence:	 The applicant must provide evidence of the following to gain RPL/RCC for this unit: Applicants may have completed a similar unit within a health course where they have conducted physical assessments on clients that involved medical history taking, palpation, observation, postural assessment (upper & lower body) and communicating clear information about services, treatment options and rationale, or 	

- Have worked within the manual therapy industries where they have conducted physical assessments on clients that involve medical history taking, palpation, observation, postural assessment (upper & lower body) and communicating clear information about services, treatment options and rationale to clients, submission of 3 different client intake forms that includes the above information is required.
- After submission of this form along with the above evidence, applicants will be required to complete a demonstration of a client intake that includes the above performance requirements.

Required Evidence:	 The applicant must provide evidence of the following to gain RPL/RCC for this unit: The candidate must show evidence of the ability to complete tasks outlined in elements and performance criteria of this unit Applicants may have completed a similar unit within a health course where they have sourced and used information from Commonwealth Government, State or Territory Government and from primary scientific research on the theory and practice of massage, or Have worked within the manual therapy industries where they have sourced and used information from Commonwealth Government, State or Territory Government and from primary scientific research within massage practice, submission of the 3 pieces of evidence is required Communication with 3 different clients/audiences using 3 different methods of communication, submission of the 3 communications is required with blacked out client identifiers

Unit Description:	This unit describes the skills and knowledge required to gather client information, prepare equipment for reflexology, make observations of the fee and then select and use basic reflexology techniques and sequences based on information and observations. This unit applies to individuals who provide reflexology relaxation sessions either as part of their work as a dedicated reflexologist or in conjunction with other treatment modalities. I does not include reflexology for therapeutic purposes.	
	The applicant must provide evidence of the following to gain RPL/RCC for this unit:	
	The candidate must show evidence of the ability to complete tasks outlined in elements and performance criteria of this unit, manage tasks	
	and manage contingencies in the context of the job role.	
Required Evidence:	 Applicants may have completed a similar unit within a health course where they have provided relaxation reflexology or 	
Evidence:	 Have worked within the manual therapy industries where reflexology has been provided as a treatment modality 	
	- Submission of client consultation forms including medical history forms for at least four (4) different people where relaxation reflexology was completed. The documents must provide evidence of competency to select reflexology techniques based on sound	

assessment of the feet: evaluated and responded appropriately to skin and structural abnormalities, used techniques and sequences within scope of reflexology thumb and finger practice, work within a health industry where direct client consultation is completed.

Note: All documents with client identifiers blanked out, demonstrating the ability to work with clients with a variety of presenting conditions clinic supervision by a person who meets the assessor requirements

• A demonstration of your ability to competently implement a reflexology for relaxation massage treatment within a full client consultation, including; interview, client questioning, physical assessment of the lower limb and foot, treatment planning, reflexology for relaxation massage treatment, evaluation, suggestions/recommendations, documentation (organised after this document has been submitted).

- Evidence of coordinating workplace procedures for a simulated emergency situations

It incorporates understanding of industry practices and professional development opportunities for massage therapists. This unit applies to massage therapists.	
	 The applicant must provide evidence of the following to gain RPL/RCC for this unit: The candidate must show evidence of the ability to complete tasks outlined in elements and performance criteria of this unit Applicants may have evidence of completing 80 hours of massage clinic work (this can include a combination of consultations, 	
	 administration, reception work, professional development etc) with a minimum of 40 consultations within a previous massage qualification within the last 3 years, or Have worked within the manual therapy industries within the last 3 years where they have completed 80 hours of massage clinic work including: 	
Required	 Evidence of 80 hours can include a combination of consultations, administration, reception work, professional development etc A minimum of 40 client consultations to clients from different stages of life with varied presentations with submission of their client intake forms and treatment documentation (client identifiers must be blacked out). 	
Evidence:	 After submission of this form along with the above evidence, applicants will be required to complete a demonstration of a full client consultation including the client intake, physical assessment, treatment planning, treatment, evaluation and documentation. Evidence must be submitted of professional development completed to identified areas of own practice for further research or development that meet their professional association membership requirements
